

Wedding Open Day 2025

Prize Draw Terms & Conditions

1. Promoter

The promoter of this prize draw is Westonbirt House, whose registered office is at Westonbirt House, Westonbirt, Tetbury, Gloucestershire, GL8 8QG.

2. Eligibility

2.1 The prize draw is open to attendees of the Westonbirt Wedding Open Day 2025 on Sunday 27th April 2025 at Westonbirt House.

2.2 Entrants must be aged 18 or over. Employees of Wishford Education, their families, agents, or anyone else professionally associated with the event are not eligible to enter.

2.3 To qualify for entry, attendees must collect 16 stamps on their entry leaflet using the provided rubber stamp at a minimum of 16 out of 24 designated locations collected during a self-guided tour of Westonbirt House and Gardens on the day of the Westonbirt Wedding Open Day 2025.

3. How to Enter

3.1 There is no entry fee and no purchase necessary to enter this prize draw.

3.2 Entries must be submitted by completing the entry leaflet and providing valid contact details, including name, email address, and phone number.

3.3 Only one entry per couple is permitted. Duplicate entries will be disqualified.

3.4 The prize draw opens on 27th April 2025 at 1.00 and closes on 27th April 2025 at 15.00. Late entries will not be accepted.

4. Prize Details

4.1 There are three prizes available:

- First Prize: £1000 off wedding venue hire at Westonbirt House booked to take place before 31st August 2026.
- Second Prize: Upgrade from Silver to Gold drinks package, or Gold to Platinum drinks package for up to 100 guests.
- Third Prize: A luxury Cotswold Hamper.

4.2 The prizes are non-transferable, non-exchangeable, and there is no cash alternative.

4.3 The venue hire discount is applicable to new bookings only and is subject to availability.

4.4 The drinks package upgrade applies only to weddings hosted at Westonbirt House on weddings booked to take place before 31st August 2026 and cannot be transferred to another venue, nor is there any cash equivalent.

5. Winner Selection & Notification

5.1 Winners will be selected at random by an independent party from all eligible entries.

5.2 The draw will take place after the event on 27th April 2026.

5.3 Winners will be notified by email or phone within 7 days of the draw. If a winner does not respond within 14 days, the prize may be forfeited and offered to an alternate winner.

6.1 By entering, entrants agree that their contact details may be used by Westonbirt House to communicate with them regarding the event and future wedding services.

6.2 Personal data will be processed in accordance with the venue's privacy policy and in compliance with UK GDPR regulations. Entrants may opt out of future marketing communications at any time.

7.1 The Promoter reserves the right to cancel or amend the prize draw and these terms and conditions where necessary due to unforeseen circumstances.

7.2 The Promoter's decision in respect of all matters relating to the competition will be final and binding.
